SELF-EMPLOYMENT SCHEME IN HARYANA

1958. SHRI DHARAMBIR SINGH:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the Government has formulated a self-employment scheme for rural areas including the State of Haryana;**
- (b) if so, the details of objectives and implementation strategy thereof;**
- (c) the funds allocated for this scheme, Statewise particularly for Haryana;**
- (d) the steps taken by the Government to ensure effective scheme implementation along with the monitoring measures and strategies to address challenges;**
- (e) the total funds allocated by the Union Government to the State Government of Haryana for rural areas during the last three years along with the purpose thereof; and**
- (f) the funds allocated and utilized in Bhiwani, Dadri and Mahendragarh districts of Haryana along with the details of all implemented schemes therein?**

ANSWER

**MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT
(SADHVI NIRANJAN JYOTI)**

(a) & (b): Yes, Sir. Ministry of Rural Development (MoRD) is implementing Rural Self Employment Training Institute (RSETI) Scheme - a bank led and MoRD funded initiative for rural areas including the State of Haryana. Under the scheme, 590 RSETIs led by concerned banks are functioning in 572 districts across 33 States and UTs in the country. RSETIs extend Skill and Entrepreneurship Development training to unemployed rural youth under 64

activities/trades approved by National Skills Qualification Framework (NSQF) and by MoRD with the objective to enable them to undertake self-employment activities according to their interests.

(c): RSETI is a demand driven programme hence state-wise allocations are not being made. The details of State-wise release of funds for 2022-23 are placed at Annexure-I.

(d): National Centre for Excellence of RSETIs (NACER) is entrusted with monitoring the performance of RSETIs under the overall supervision of MoRD. Further, Regular monitoring Phase-I 2022-23 was conducted in January-February 2023 in 264 districts of the country through empanelled National Level Monitors (NLMs) for proper implementation of various MoRD schemes including RSETIs.

(e) & (f): The details of funds allocated/released/utilised under various rural development schemes of MoRD for Haryana during last three years (and applicable district-related information) are given at Annexure-II with relevant footnotes.
