## GOVERNMENT OF INDIA MINISTRY OF HOUSING AND URBAN AFFAIRS LOK SABHA UNSTARRED QUESTION NO. 196 TO BE ANSWERED ON JULY 20, 2023

#### **CREDIT RATING OF CITIES**

#### NO. 196. SHRI BENNY BEHANAN:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the average credit rating calculated for urban cities as per the reforms under AMRUT;
- (b) the reasons for the integration of Central and State implementation in the working of the AMRUT scheme along with the details of responsibility structure;
- (c) the progress made in water connectivity under the AMRUT Scheme during the last three years; and
- (d) whether the Government has any explanation for the substantial difference in funding ratios between the completed 4,676 projects worth INR 32,793 crores under the AMRUT scheme and the 1,197 projects worth INR 49,430 crores that are at various stages of implementation, considering the significantly smaller number of projects in the latter category and if so, the details thereof?

#### ANSWER

### THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a): Under Atal Mission Rejuvenation and Urban Transformation (AMRUT) Reforms, Credit rating work for 485 cities have been awarded and completed in 470 cities. Out of 470 cities, 164 cities have received Investible Grade Rating (IGR), including 36 cities with rating of A- or above, spread across 12 States/ UTs and 306 cities received Non- Investible Grade Rating (Non-IGR). The details of grade-wise no. of cities are at ANNEXURE. (b): Sanitation, water supply and urban development are State subjects. The Central Government, through various program interventions including AMRUT, supplements the efforts of State/ Union Territories (UTs) in improving these facilities. The objective of empowering of States integration of central and State implementation in the working of the scheme like AMRUT have been done in which the centre only approves the State Annual Action Plans (SAAPs) while the States develop, appraise, approve, award and execute the projects.

(c): During the last three years, since 01 July 2020, 93 lakh water tap connections have been provided/ serviced under AMRUT Mission and Convergence in 500 AMRUT cities.

(d): 4,676 projects comprise large number of smaller projects worth less than ₹30 crore while 1,197 projects comprise bigger size of projects. In ongoing 916 projects about 77% of work has been physically completed.
