Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the details of the Food Processing Units (FPUs) presently functional across the various States of the country, particularly in Dadra & Nagar Haveli, Daman & Diu and Maharashtra;
- (b) whether the Government proposes to set up multiple FPUs in Dadra & Nagar Haveli, Daman & Diu and Maharashtra;
- (c) if so, the details thereof;
- (d) whether the Government has formulated any long-term scheme for the processing of agricultural products in the rural areas of Dadra & Nagar Haveli, Daman & Diu and Maharashtra;
- (e) if so, the details thereof and if not, the reasons therefor; and
- (f) the various measures taken by the Government to boost the development of food processing sector in the country?

#### ANSWER

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a): The number of registered units, engaged in food products and beverages manufacturing across the country, including Dadra & Nagar Haveli, Daman & Diu and Maharashtra, as per Annual Survey of Industries 2019-20, is placed at **Annexure-I.** 

(b) to (f): Ministry of Food Processing Industries(MoFPI) does not set up any Food Processing Industries on its own. However, it incentivizes setting up/expansion of related infrastructure through its Central Sector Umbrella Scheme Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) scheme across the country including rural areas of Dadra & Nagar Haveli, Daman & Diu and Maharashtra. These schemes are inter-alia aimed at increased processing of agro- products. Under component schemes of PMKSY, MoFPI provides mostly credit linked financial assistance (capital subsidy) in the form of grants-in-aid to entrepreneurs. Ministry also provides financial, technical and business support for setting up/upgradation of micro food processing enterprises through credit linked subsidy under PMFME scheme. PLISFPI is targeted to facilitate expansion of food processing capacity by creating champion brands in Food Processing Sector. The details of Food Processing Units supported through these schemes in Dadra & Nagar Haveli, Daman & Diu and Maharashtra is placed at **Annexure-II**.
