Will the Minister of AGRICULTURE AND FARMERS' WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the aims and objectives of Micro Irrigation Fund (MIF);
- (b) whether it is true that the fund amount has increased to Rs. 10,000 crore in 2021-22;
- (c) the details of projects approved, landed and completed under Micro Irrigation Fund scheme since its implementation, State and year-wise; and
- (d) the details regarding area of hectares which have been approved under MIF, with a particular reference to Telangana?

ANSWER

MINISTER OF AGRICULTURE AND FARMER'S WELFARE कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

- (a) & (b): With a view to provide impetus to Micro Irrigation systems and to enhance water use efficiency in agriculture sector, a Micro Irrigation Fund (MIF) with corpus of Rs. 5000 Crore was created with NABARD during 2018-19. The main objective of the Fund is to facilitate the States in mobilizing the resources to provide top up/additional incentives to farmers for incentivising micro irrigation beyond the assistance available under Per Drop More Crop (PDMC) Scheme. States may also access MIF exclusively for innovative/integrated projects depending on State specific requirements. Further, to strengthen and expand adoption of micro-irrigation systems by the farmers in the country, an announcement has been made in the Union Budget 2021-22 to augment the initial corpus of MIF by another Rs. 5000 crores.
- (c): The projects received from States of Andhra Pradesh, Tamil Nadu, Haryana, Gujarat, West Bengal, Punjab, Uttarakhand and Rajasthan have been approved for Rs. 4710.96 Crores of loan under MIF, out of which an amount of Rs. 2516.0224 Crores has been disbursed to these States, so far. Details of State-wise projects sanctioned, loans disbursed and targeted MI Area under MIF are given in the **Annexure**.
- (d): So far, State of Telangana has not submitted any projects under MIF.
