- (b) the details of funds utilised for the help of eligible startups during 2022-23, State-wise particularly in Odisha;
- (c) whether there is any performance monitoring system of the said scheme; and
- (d) if so, the details in this regard?

ANSWER

(a) to (d): The Government under Startup India initiative implements the Startup India Seed Fund Scheme (SISFS) which was approved for a period of 4 years starting from 2021-22 with a corpus of Rs. 945 crore. The Scheme provides financial assistance to startups for proof of concept, prototype development, product trials, market entry and commercialization. The Schemeis being implemented from 1st April 2021.

The Experts Advisory Committee (EAC), under SISFS, is responsible for the overall execution and monitoring of SISFS. The EAC evaluates and selects incubators for allocation of funds under the Scheme. Each selected incubator has an Incubator Seed Management Committee (ISMC), consisting of experts who evaluate and select startups based on certain parameters outlined in Scheme guidelines. (as available online at https://dpiit.gov.in/startup- india/startup-india-initiative).

As on 30th April 2023, Rs. 611.36 crore has been approved for 160 incubators by the EAC under SISFS. The approved incubators have selected 1,039startups for financial support of Rs. 176.63 crore.
