Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of Micro and Small Enterprises to which credit guarantee facility has been provided under the Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), State-wise, particularly in Himachal Pradesh, district-wise;
- (b) the number of application received for availing benefits under the said scheme i.e. CGTMSE Scheme from various States including Odisha, Rajasthan, Uttar Pradesh, Himachal Pradesh and Gujarat, especifically from Balasore, Pali, Jhansi, Pratapgarh, Deoria, Shimla, Solan, Sirmaur, Navsari and Surat districts, respectively along with sanctioned guarantees therefor;
- (c) whether the Government has framed any guidelines which the lending institutions are required to adhere to while selecting beneficiaries under the said scheme; and
- (d) if so, the details thereof and if not, the reasons therefor?

- (a) & (b): The details of the cumulative credit guarantee extended to Micro and Small Enterprises, State-wise, including district –wise details of Himachal Pradesh, are given in Annexure-A and Annexure–B respectively. The details of number of guarantees approved and the amount of guarantees approved under the CGTMSE in Balasore, Pali, Jhansi, Pratapgarh, Deoria, Shimla, Solan, Sirmaur, Navsari and Surat districts are attached in Annexure-C.
- (c) & (d): The Credit Guarantee Fund Trust for Micro and Small Enterprises provides guarantee for the credit extended by Member Lending Institutions (MLIs) to Micro & Small Enterprises, without collateral and third party guarantee and for the activities eligible as per MSMED Act 2006. To extend the credit to borrowers, MLIs follow extant guidelines of their respective institutions.
