# A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

(a): As on 01.07.2023, 36 warehouses (14 owned+ 22 hired) are being operated by Food Corporation of India (FCI) in Gujarat.

(b) & (c): Yes, Sir. FCI continuously assesses and monitors the storage capacity and based on the storage gap assessment, storage capacities are created/hired.

FCI augments its storage capacity through following schemes:

1. Private Entrepreneurs Guarantee (PEG) Scheme

2. Central Sector Scheme (CSS).

3. Construction of SILO's under PPP mode

4. Hiring of godown from Central Warehousing Corporation (CWC)/ State Warehousing Corporation (SWCs)/State Agencies

5. Hiring of godown through Private Warehousing Scheme (PWS)

Further, details of construction of silos taken up by FCI in Gujarat are as given below:-

(i) Silos at Amreli and Baroda with a capacity of 0.50 LMT each are under implementation.

(ii) Details of silos under Phase-I of Hub & Spoke model are at Annexure-I.

(iii) The proposed silos under Phase-II of Hub & Spoke model are at Annexure-II.

Additional storage capacity of 19580 MT is proposed on FCI vacant land at FSD Dared of district Bhavnagar under Asset Monetization.
