- (a) the details of the fund allocation and utilization of the Price Stabilization Fund (PSF) in the last five years, State-wise;
- (b) the details of the current status of the State level Price Stabilization Fund of Jharkhand; and
- (c) the initiatives taken by the Government to monitor the PSF and Utilization Certificates based on the recommendation of the Standing Committee on Food, Consumer Affairs and Public Distribution?

- (a): The details of year-wise budgetary support allocated under Price Stabilisation Fund (PSF) Scheme and the amount utilised and also the State-wise details of funds released from PSF Corpus for setting up State-level PSF in last five years are given at **Annexure-I**.
- (b): Government of Jharkhand had submitted a proposal, vide letter dated 21.09.2021, for creation of State-level PSF. The proposal was examined and details were sought from the State Government via e-mail dated 25.10.2021. Further reminders were sent to the State, vide letters dated 31.12.2021, and followed up with letters on 03.06.2022 and 27.07.2023. The State Government has not responded till date.
- (c): The Department of Consumer Affairs is proactively pursuing the States to utilise the funds provided for setting up State-level PSF by holding meeting with the States which availed of the fund. Separately, meetings had been held with States Governments which have not availed of the fund for setting up their own State-level PSF.
