FUNDING PATTERN UNDER SAMARTH

2204. SHRI RAJA AMARESHWARA NAIK:

Will the Minister of TEXTILES वस्त्र मंत्री
be pleased to state :

- (a) whether the funding pattern under the Scheme for Capacity Building in Textiles Sector (SAMARTH) has been revised with an increment of 5 per cent in cost norms;
- (b) if so, the details thereof;
- (c) whether the Government has recently partnered with 157 Textile Industries/Industry Associations, 16 Central/State Government Agencies for undertaking training programmes under SAMARTH and if so, the details thereof;
- (d) whether more than 85 per cent of the beneficiaries trained so far under the scheme are women and more than 70 per cent of the beneficiaries trained, was provided placement and if so, the details thereof; and
- (e) the other steps being taken by the Government for creating more jobs in the Textile sector?

- (a) & (b):** The funding pattern under Samarth has been revised with an increase of 5% for ongoing batches and all future batches w.e.f 11.07.2023, aligning with Common Cost Norms determined by Ministry of Skill Development and Entrepreneurship.
- (c):** The Government has partnered with 157 textile industry/industry associations and 16 State/Central government agencies for undertaking training programmes under Samarth. Details of Textile Industries/ Industry Associations are given in **Annexure I** and details of Central/State Government Agencies are given in **Annexure II**.
- (d):** Out of the overall beneficiaries of 1,85,467 trained (passed) under Samarth as on 27.07.2023, 1,61,357 (87%) beneficiaries are women. Out of the overall beneficiaries of 1,39,546 trained (passed) under organized sector courses as on 27.07.2023, 1,05,716 (75.8%) beneficiaries have been provided placement by implementing partners.
- (e):** Ministry of Textiles has been implementing various schemes viz, Production Linked Incentive (PLI) Scheme, Pradhan Mantri Mega Integrated Textile Region and Apparel (PM MITRA), Amended Technology Upgradation Scheme (ATUFS), Silk Samagra, National Handloom Development Programme, National Handicraft Development Programme, Integrated Wool Development Programme (IWDP), National Technical Textile Mission (NTTM), Scheme for Integrated Textile Parks (SITP) etc. for overall development of textile industry in the country and inter alia supporting creation of more jobs in the textile sector.
