Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

(a) the number of beneficiaries that enrolled under Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) in the country since 2019;

(b) the details of building and construction workers welfare fund released to provide relief to construction workers since 2020, State-wise; and

(c) the number of registered poor senior citizens, widows and disabled beneficiaries under PMGKAY till 30 June 2023, State-wise?

A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

In view of the pro-poor initiative announced by the Government of India to (a): ameliorate the hardship faced by the poor due to economic disruption caused by Corona virus, this Department has implemented Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY) in seven (7) phases from April 2020 to December 2022 for distribution of additional free-of-cost foodgrains to all States/UTs. Around 80 Crore National Food Security Act (NFSA) beneficiaries in the country are entitled to get benefits of PMGKAY. However, the Central Government to remove the financial burden of the poor beneficiaries and to ensure nationwide uniformity and effective implementation of the Act, has decided to provide food grains free of cost to Antyodaya Anna Yojana (AAY) households and Priority Households (PHH) beneficiaries under NFSA, for a period of one year beginning from 1st January 2023. As per Central Government decision, inter-alia two food subsidy schemes have been subsumed as Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY). Under this scheme Free foodgrain is being distributed through Targeted Public Distribution System (TPDS) from 1st January 2023.

(b): Ministry of Labour & Employment (MoLE) administers the Building and Other Construction Workers (BOCW) (RE&CS) Act 1996 and BOCW Welfare Cess Act, 1996 and their rules, whereas, as per Section 3 of the BOCW Welfare Cess Act, 1996, the State Governments are mandated to collect the Cess and as per Section 22 of the BOCW (RE&CS) Act, 1996, the State / UT Governments through State / UT Building and Other Construction Workers' Welfare Boards are empowered and entrusted for making provisions for providing Social Security and implementation of welfare schemes for Building and Other Construction Workers relating to life and disability cover, health and maternity cover, financial assistance for education of wards of the registered Building and Other Construction Workers, transit housing, skill development, awareness programs, pension etc. Further, the amount spent by the State Welfare Board is attached as Annexure-I.

In order to mitigate the financial crisis of the Building and Other Construction Workers (BOCW) and protect them against the economic disruptions during Covid-19 pandemic and Country-wide lockdown, the Government of India had taken numerous measures to provide them financial assistance, food packages and other benefits. Advisory guidelines were issued under Section – 60 of the Building and Other Construction Workers Act, 1996 to all the States/UTs Building and Other Construction Workers Welfare Boards to frame a scheme for transfer of adequate funds in the bank account of construction workers through direct benefit transfer (DBT mode) from the Cess funds collected by the States/UTs. In response, the State Welfare Boards have cumulatively disbursed around Rs. 5618 Crores, through DBT, to the bank accounts of 1.83 Crores (approx.)BOC Workers during the first wave of Covid – 19. Similarly, during second wave of COVID-19, Rs. 1795 Crores were disbursed through DBT to more than 1.23 crores BOC Workers by the State BOCW Welfare Boards. Details of cash relief to BOC workers during Pandemic is attached as Annexure-II.

As per the Targeted Public Distribution System (TPDS) Control Order 2015, (c): the review of ration cards/beneficiaries list, identification of ineligible/ duplicate ration cards and inclusion of eligible beneficiaries/households is the responsibility of concerned State/UT Government. States/UTs have been advised to undertake proper verification (including field verification) of each identified case to ensure that ration cards of genuine beneficiaries are not deleted/ suspended. Further, ration cards the eligible States/UTs regularly issue new to households/beneficiaries in place of cancelled ration cards within ceiling limit of the National Food Security Act (NFSA). However, the data of senior citizens, disabled, widow is not maintained by the Department. State-wise list of NFSA beneficiaries is attached as Annexure-III.
