## FILLING UP VACANT POSTS

Will the Minister of RAILWAYS be pleased to state:
(a) whether the Government is aware of the severe staff shortage faced by the Indian Railways, with several gazetted and more than 3.12 lakh non-gazetted posts lying vacant across 18 zones and if so, the details thereof, zone/division-wise:
(b) whether the Railways has taken any measures to address the shortage of staff in all the zones including Ernakulam, Kerala and thereby prevent potential train accidents and disasters and if so, the details thereof;
(c) whether the Government has fixed a timeline or target for filling all the vacant posts and if so, the details thereof and if not, the number of gazetted/non-gazetted posts lying vacant across the country, zone-wise;
(d) whether the Government has implemented any measures to expedite the recruitment process and ensure timely appointments and if so, the steps taken in this regard;
(e) whether the inability to fill the posts has led to employees working over-time of upto 16 hours at a stretch without rest and food and if so, the facts thereof;
(f) whether the Government has identified specific challenges in the recruitment to the vacant posts and if so, the plan envisaged to address these challenges;
(g) the number of employees engaged by the Railways on contract basis during the last five years, year/zone/division-wise; and
(h) whether permanent railway personnel are more responsible and accountable towards their duties in comparison to the contractual staff which affects the Railways operating system and if so, the details thereof?

(a) to (f): The details of total vacancies, zone-wise in Indian Railways as on 01.07.2023 are as under:

The vacancies of Operational Safety categories are 53,178.
Occurrence and filling up of vacancies are continuous process on Indian Railways considering its size, spatial distribution and criticality of operation. The vacancies are filled up primarily by placement of indents by Railways with Recruitment agencies as per operational requirements.

Direct recruitment to Group ' $A$ ' Services on Indian Railways is mainly done by UPSC. Every year Indent is placed on UPSC and DoPT.

A massive recruitment exercise has been completed recently for empanelling $1,39,050$ candidates by conducting Computer Based Test (CBT) of approximately $\mathbf{2 . 3 7}$ crore candidates.

CBT for Centralized Employment Notification (CEN) 01/2019 for NonTechnical Popular Categories (NTPC) was conducted for $\mathbf{1 . 2 6}$ crore candidates in 133 shifts in 68 days across 211 cities and 726 centres in 15 languages. Similarly, CBT for CEN-RRC 01/2019 (Level-1) was conducted for 1.11 crore candidates in 99 shifts in 33 days across 191 cities and 551 centres in 15 languages.

During period from 01.04 .2022 till 30.06.2023, 1,36,773 candidates have been empanelled against various Group ' $C$ ’ posts (including Level 1). This includes $1,11,728 *$ safety category posts.

All efforts are being made to fill up vacancies in Southern Railway including Thiruvananthapuram Division and in units/offices located at Ernakulam. 3361 candidates have been empanelled for appointment to Group 'C' (excluding Level-1) posts in Southern Railway. 8514 candidates have been empanelled for appointment to Level-1 posts in Southern Railway.

Vacancies are being filled up in a regular manner either through direct recruitment or promotion. No such instance of employees
working up to 16 hours at a stretch without rest and food has come to notice.
