Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state;

- (a) the number of Micro, Small and Medium Enterprises (MSMEs) units registered on the Udyam Registration Portal from the States of Uttar Pradesh, Rajasthan, Odisha and Gujarat, particularly from Jhansi, Pratapgarh, Deoria, Pali and Balashore Parliamentary Constituencies;
- (b) whether the Government proposes to increase the maximum reimbursement given to an exporter under the 'Capacity Building of First-Time MSME Exporters' (CBFTE) scheme and if so, the details thereof;
- (c) the number of micro and small units from the said States that availed the benefits under the CBFTE scheme;
- (d) whether the Government has taken any steps for providing marketing support especially to micro and small enterprises; and
- (e) if so, the details thereof and if not, the reasons therefor?

(a): As per the Udyam Registration Portal, the number of Micro, Small and Medium Enterprises (MSMEs) registered on the Udyam Registration Portal, in the four States of Gujarat, Odisha, Rajasthan and Uttar Pradesh, w.e.f. 01.07.2020 till 31.07.2023, are as under:

(b): At present, there is no proposal to increase the maximum reimbursement given to the Micro and Small Exporters under CBFTE Component of International Cooperation Scheme.

(c): Under CBFTE Component of IC Scheme, funds are not allocated/released State-wise/UT-wise; instead, funds are released through implementing agencies i.e. Export Promotion Councils (EPCs), Export Credit Guarantee Corporation Limited (ECGC) and National Small Industries Corporation Limited (NSIC) engaged by the Ministry for reimbursement of costs incurred by Micro and Small Enterprises (MSEs) on Registration-cum-Membership Certification (RCMC) charges, Export Insurance Premium and Testing & Quality Certification. Details of funds released for benefiting MSEs through EPCs, ECGC and NSIC during 2023-24 is tabulated below:
