### **Madarsa Schools**

## 2419. DR. TALARI RANGAIAH:

Will the Minister of Minority Affairs be pleased to state:

- (a) whether the Government maintains data of Madarsa Schools running in the country;
- (b) if so, the details of the number of Madarsa schools running in the country, State/UT-wise;
- (c) the number of students enrolled and teachers who are working in the said Madarsa schools in the country, State/UT- wise,
- (d) whether the Government proposes to build their infrastructure and capabilities; and
- (e) if so, the details thereof and if not, the reasons therefor?

### **ANSWER**

# THE MINISTER OF MINORITY AFFAIRS (SHRIMATI SMRITI ZUBIN IRANI)

- (a) to (c): Ministry of Minority Affairs does not maintain data of Madarsa Schools running in the country. As per information provided by the Department of School Education and Literacy, Ministry of Education, there are 23,613 recognized and unrecognized Madarsa schools registered on the UDISE+ Portal in the year 2021-22. The State/UT-wise number of Madarsa schools, students enrolled and number of teachers in these schools is given in annexure.
- (d) and (e): Education is in the concurrent list of the Constitution and majority of the Madarsa schools are under domain of respective State and UT Governments. Ministry of Minority affairs implements Pradhan Mantri Jan Vikas Karyakram (PMJVK), a Centrally Sponsored Scheme (CSS), which is an area development programme under which community infrastructure and basic amenities are being created in the identified areas. Education is one of the priority sectors under PMJVK and projects such as construction of schools, additional classrooms, hostels, computer labs/digital classrooms, science laboratories, drinking water facilities and toilets in schools, etc are supported under the scheme, as per the scheme guidelines. The scheme is being implemented under the aegis of the State Governments/ Union Territory (UT) Administrations on a fund sharing pattern and the assets created are implemented and managed by the concerned State/ UT Government. The scheme has been approved with effect from financial year 2022-23 with the revised guidelines, for implementation in all districts of the country during the period of 15th Finance Commission Cycle.
