(a) to (d) Under the newly approved Mission Shakti, Swadhar Greh - for women in difficult circumstances and Ujjawala Home - for prevention of trafficking have been merged and renamed as Shakti Sadan which is an Integrated Relief and Rehabilitation Home for the women in distress situations and difficult circumstances. Shakti Sadan is a demand driven Centrally Sponsored Scheme under which funds are directly released to States/UTs governments for the implementation of the Scheme. The funds released during the last three years period with regard to Shakti Sadan (erstwhile SwadharGreh) is at **Annexure-I.** State/UT-wise number of Shakti Sadan and beneficiaries including Maharashtra, Dadra and Nagar Haveli and Daman and Diu is at **Annexure-II.**
