Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:-

- a. whether it is true that a large quantity of finished plastic goods have been imported in the country;
- b. If so give details thereof indicating the quantum of imports made during the last three years, year-wise;
- c. whether the government has received any representation to curb the import of plastic goods in the country;
- d. if so, the details thereof;
- e. whether the Government has received any proposal to increase import duty on finished plastic goods in the country; and
- f. if so, the details thereof along with the response of the Government in this regard?

- (a) Yes, a large quantity of finished plastic goods have been imported in the country.
- (b) The imports of plastic articles during the last three years, year-wise are as under: (Import Value in Rs.Cr)

(c) & (d) The representations were received from All India Plastics Manufacturers Association (AIPMA), Organization of Plastics Processors of India (OPPI), Plastindia Foundation and Plexconcil requesting an increase in basic customs duty on finished plastic products from 10-15 % to 25%. The finished plastic goods attract a 10-15% BCD (Basic Customs Duty) + 10% Social Welfare Surcharge Cess (SWS) on BCD + 12/18% IGST.

(e) & (f) The proposal for increase in import duty on finished plastic goods was examined as part of Union Budget 2023-24 and it was decided not to make changes to the rate.
