Will the Minister of **AYUSH** be pleased to state:

- (a) the number of recognized Graduate and Post Graduate colleges functional under the Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy (AYUSH) systems of medicine in the country, State/UT-wise;
- (b) the funds allocated released to such colleges along with its utilization during the last three years and the current year, State/UT-wise;
- (c) the number of students who have successfully completed their Graduate courses during the last three years and the current year, State/UT-wise;
- (d) whether the AYUSH degree certificates are recognized globally and, if so, the details thereof and if not, the reasons thereof; and
- (e) the step taken/proposed to be taken by the Government for proper monitoring of the utilization of such funds in the country?

ANSWER

THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) The number of recognized Graduate and Post Graduate colleges functional under the Ayurveda, Unani Siddha and Homoeopathy systems of medicine in the country, State/UT-wise, is placed at **Annexure-I.**

Further, currently, Undergraduate and Postgraduate courses of Yoga and Naturopathy are not being regulated under the Ministry of Ayush. However, various institutes/courses of Yoga and Naturopathy are recognized/affiliated with Medical Universities/State Universities.

(b) Public Health being a State subject, setting up of AYUSH Medical Colleges comes under the purview of State/UT Governments. However, Under the Centrally Sponsored Scheme of the National Ayush Mission (NAM), there is the provision of financial assistance to States/UTs for the upgradation of UG / PG Ayush educational institutions. The State/UT Governments may avail of eligible financial assistance by submitting suitable proposals through State Annual Action Plans (SAAPs) as per the provisions of NAM guidelines. As per

the proposals received through SAAPs, the State/UT-wise status of funds allocated/released to different Ayush colleges in the country during the last three years and the current year is attached as **Annexure-II**.

- (c) The information on the number of students who have successfully completed their Graduate courses and registered in the respective State Ayush medical registration board during the last three years and till date, State/UT-wise, is placed at **Annexure III.**
- (d) Currently, Ayurveda is recognized and regulated in Bahrain, Bangladesh, Cuba, Malaysia, Mauritius, Nepal, Oman, Pakistan, Srilanka, Tanzania, and United Arab Emirates. Other than Ayurveda, the remaining Ayush systems of medicine, like Siddha are recognized in Sri Lanka, Malaysia and UAE; Unani is recognized in Bangladesh, Sri Lanka, Pakistan and UAE; and Sowa Rigpa is recognized in Bhutan and Mongolia as a system of medicine
- (e) With regard to the effective utilization of the released grant under NAM, State/UT Government has been requested to furnish the Physical & financial progress report to the Ministry at regular intervals. Further, time-to-time physical visit, as well as review meeting, is also being conducted to monitor the progress of effective utilization of the released funds.
