Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether 11,000 urban Health and Wellness Centres are proposed to be set up in different States and if so, the details thereof, State/UT-wise;

- (b) if so, the details of the urban Health and Wellness Centres set up in Telangana;
- (c) the details of Public Health Labs proposed and set up in Telangana so far;
- (d) the details of the districts in Telangana with more than 5 lakh population;
- (e) whether under PM Ayushman Bharat Health Mission, Ministry/Government proposes to set up critical care hospital blocks in all districts with population of more than 5 lakhs; and
- (f) if so, the details thereof along with progress made in this regard in Telangana?

ANSWER

(a) & (b): Under PM Ayushman Bharat Health Infrastructure Mission, 11,024 Ayushman Bharat-Health and Wellness Centres are envisioned to be set up in urban areas across the country over five years. The State/UT -wise details of proposed urban HWC has been attached at Annexure -I. A total of 1278 UHWCs have been allotted through XV-Finance Commission and PM-ABHIM from

2021-22 to 2025-26. As per information available on the PMS portal, establishment of 237 UHWCs has been completed in the State.

(c): In Telangana, approval has been accorded for an amount of Rs.67.74 crore for setting up of 33 Integrated Public Health Labs (IPHL) at District level. Out of 33 IPHLs, 20 labs have been established as on 31.07.2023.

(d): There are total 33 Districts in Telangana. Out of these, only 2 Districts have population less than 5 lakhs namely Jayashankar Bhupalpally and Mulugu. List of 31 districts with population greater than 5 lakhs has been attched at Annexure -II.

(e) & (f): Under PM-ABHIM, support is provisioned for States/UTs under CSS component of the scheme for establishing Critical Care Hospital Blocks (CCBs) in 602 districts (with population more than 5 lakhs). Administrative approvals have been accorded to State of Telangana for an amount of Rs.915.79 Crore for construction/strengthening of 31 CCB.
