**Recognition of Home Schooling**

Will the Minister of EDUCATION be pleased to state:

- (a) the number of students receiving home schooling, State-wise & UT-wise;
- (b) whether the Government proposes to address the concerns of parents regarding the recognition and acceptance of home schooling as a legitimate educational alternative in India;
- (c) the details of the steps taken by the Government to bridge the digital divide and provide equitable access to online learning platforms and resources for home schooled students across the country; and
- (d) the initiatives or policies taken by the Government to enhance the professional development and training opportunities for home schooling parents, in order to ensure effective instruction and learning outcomes for their children?

**ANSWER**

- (a) The State & UT wise number of students receiving home schooling is at **Annexure-I**.
- (b) to (d) The National Education Policy (NEP), 2020 advocates full equity and inclusion as the cornerstone of education to ensure that all students are able to thrive in the education system. The policy recommends providing the choice for home-based education for children with severe and multiple disabilities who are unable to go to schools. The Samagra Shiksha scheme has been aligned with the NEP 2020 to ensure that all children have access to quality education.

The Centrally sponsored Samagra Shiksha – is an integrated scheme for School Education of the Department of School Education & Literacy, Ministry of Education, covers all children including children with special needs. Under Samagra Shiksha, there is a dedicated component for Inclusive Education for Children with Special Needs (CwSN) through which various provisions are made available for the educational needs of CwSN such as, provision of aids, appliances, assistive devices & teaching learning materials (TLMs) etc. under the scheme. This includes home based education for children with multiple &/ severe disabilities who are unable to attend school. For the year 2023-24, support for 72,186 CwSN, who are enrolled in the

home-based education programme has been approved, with an estimated outlay of ₹2,067.93 lakh.

Parenting is of great significance in the current age of disruption in all spheres of life. Parent and community participation can go a long way in helping children overcome the challenges that they face and providing a safe and conducive environment for learning. Parents and care givers can contribute immensely in providing appropriate learning experiences to their children. MoE has developed guidelines for Parent participation in Home based learning for which link is given below:

A comprehensive initiative called PM eVIDYA has been initiated as part of Atma Nirbhar Bharat Abhiyaan, which unifies all efforts related to digital/online/on-air education to enable multi-mode access to education. The eContents/ programme uploaded under PM eVidya are based on NCERT curriculum. Besides this many States have also offered and uploaded their e-Contents for PM eVidya, in line with the curriculum of their education boards/SCERTs. The initiative includes:

- DIKSHA the nation's digital infrastructure for providing quality e-content for school education in States/UTs and QR coded Energized Textbooks for all grades (one nation, one digital platform). As on 27.07.2023 DIKSHA has more than 524 crores learning sessions, more than 6,125 crore learning minutes with more than 1.63 crore average daily page hits. A total of 3,17,496 pieces of e-contents are live on DIKSHA as on date.
- PM eVidya DTH TV live Telecast –
  - (i) Class 1 to 10 Live programmes - 3,021 Live interactive sessions of 30 minutes each have been telecast on class-based channels (1 to 10). It covered about 1,510.30 hours of telecast.
  - (ii) Class 11 & 12 Live programme: 296 live interactive sessions of 60 minutes each have been telecast based on class-based channels (11 & 12). It covered about 296 hours of telecast.
- E-content for visually and hearing impaired:
  - (i) About 4,210 audiobook chapters have been developed and uploaded on DIKSHA.
  - (ii) Teaching Learning Interventions for Inclusive Classrooms: 594 live sessions of 'Teaching Learning Interventions for Inclusive Classrooms' of half an hour have been transmitted live covering about 297 hours.
