2848. SHRI ARUN KUMAR SAGAR:

Will the Minister of FINANCE be pleased to state:

- (a) whether the nationalized banks have organized the programmes related to centrally operated schemes like Pradhan Mantri Mudra Yojana, Stand Up India Yojana, Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Atal Pension Yojana etc., in Shahjahanpur Constituency of Uttar Pradesh;
- (b) if so, the place-wise/date-wise details of the programmes organized in Shahjahanpur Constituency during the last three years;
- (c) whether the nationalized banks have invited the local public representatives in each programme organized in Shahjahanpur Constituency during the above period;
- (d) if so, the details thereof;
- (e) if not, the reasons therefor; and
- (f) the steps taken by the Government to ensure participation of local representatives in the programmes related to operation of central schemes by the nationalized banks?

ANSWER

(a) Banks have organised various programmes in Shahjahanpur constituency of Uttar Pradesh in tandem with local administration and other stake holders for schemes like Pradhan Mantri Mudra Yojana, Stand Up India Yojana, Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Atal Pension Yojana etc.

(b) to (f) State Level Banker's Committee (SLBC), Uttar Pradesh (UP) has informed that invitations are sent to the various categories of public representatives while organising programmes under these schemes. Details of the programmes organised and public representatives who participated in the programmes organised in Shahjahanpur Constituency during last three years is placed at Annexure I. Department of Financial Services has written to SLBC, UP to ensure the presence of Public Representatives like MPs/MLAs etc. in the meetings of the District Level Review Committees (DLRCs) and also in all the credit outreach programmes in relation to the various Government Schemes.
