Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि और किसान कल्याण मंत्री be pleased to state:

(a) the progress made in the implementation of Agriculture Technology Management Agency (ATMA) Scheme;

(b) the details of allocation and utilization of funds under the ATMA Scheme during each of the last three years, State-wise;

(c) whether it is true that there is a need to further extend the said scheme so as to reach more people and if so, the response of the Government in this regard;

(d) whether the Government has allocated any funds to the State of Uttar Pradesh under the said scheme during the Financial Years 2020-21, 2021-22 and 2022-23 and if so, the details thereof;

(e) whether the Government has number of farmers who were trained to improve skills in agriculture and other allied sectors by the ATMA scheme through camps or farmers schools and if so, the details of such programme held in the country particularly district-wise details of Haryana State; and

(f) whether there is any special provision to provide extensive training for organic farming/allied activities to female and/ or SC/ST farmers and if so, the number of such trained persons in Haryana particularly in the Parliamentary Constituency of Sirsa during FY 2019-22?

### ANSWER

# MINISTER OF AGRICULTURE AND FARMERS WELFARE

(a): Agricultural Technology Management Agency (ATMA) Scheme is under implementation across the country since 2005 aimed at creating awareness amongst farmers about new technologies. Presently, Scheme is being implemented in 704 districts of 28 states & 5 UTs [Including all the 22 districts of Haryana and 75 districts of Uttar Pradesh]. The scheme promotes decentralized farmer-friendly extension system in the country. Under the scheme Grants-in-Aid is released to the State Governments with an objective to support State Government's efforts to make available the latest agricultural technologies and good agricultural practices in different thematic areas of agriculture and allied sectors to farmers through different extension activities viz; Farmers Training, Demonstrations, Exposure Visits, Kisan Mela, Mobilization of Farmers Groups and organizing Farm Schools etc.

The state-wise details of farmers benefitted through different extension activities under the ATMA Scheme during last three years is enclosed at **Annexure-I**.

(b): The state-wise details of Allocation, Release and Utilization of funds to carry out extension activities under the ATMA Scheme for the last three years i.e. 2020-21 to 2022-23 is enclosed at **Annexure-II**.

(c): ATMA is a platform at district level for integrated extension delivery involving all the stake holders. About 40 lakh farmers are annually benefitted under the scheme through different extension activities. Evaluation Study conducted by NITI Aayog in 2020 recommended to continue the Scheme with more focus on field demonstrations.

(d): Yes. The year-wise details of funds allocated to the State of Uttar Pradesh under ATMA Scheme during the financial years 2020-21, 2021-22 and 2022-23 is given in the following table: -

(e): Yes. During the last 3 years, 5,34,896 farmers have been trained in different thematic areas at different levels under Farmers Training and Farm Schools activities in the country including 86792 farmers of Haryana State. District-wise details of Haryana State is enclosed at **Annexure-III**.

(f): There is no specific provision to provide extensive training for organic farming/allied activities. However, Scheme Guidelines provide for allocating at least 30% of resources for the benefit of Women Farmers and Women extension functionaries. Funds are released to States in proportion to population of General/SC/ST categories of farmers' in the State as per Census, 2011. A total of 16085 farmers have been benefitted through training in the parliamentary constituency of Sirsa of Haryana State during the period 2019-2022.
