### **PMAY-G IN ANDHRA PRADESH**

### **3060. SHRI KESINENI SRINIVAS:**

### Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of houses sanctioned, pending and completed under Pradhan Mantri Awaas Yojana - Gramin (PMAY-G) during each of the last four years, State-wise particularly in Andhra Pradesh;
- (b) whether it is a fact that no new housing units have been sanctioned in Andhra Pradesh after financial year 2021-22 and if so, the reasons therefor;
- (c) the measures being taken by the Government to reduce time lags in verification for approval of installments to beneficiaries;
- (d) whether the Government intends to redesign the loan product under the yojana to offer minimum collateral requirements and cheaper interest rates to beneficiaries seeking extra financial assistance; and
- (e) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

# MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a): The State/ Union Territory (UT) wise details of houses sanctioned and completed under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G), particularly in Andhra Pradesh during each of the last four years (2019-20 to 2022-23), as on 03.08.2023 is given in Annexure.
- (b): The Ministry had allocated target of 1,79,060 houses to the State of Andhra Pradesh during FY 2021-22 as full and final target from the finalised Awaas+, 2018 list. The State Government had already sanctioned 1,78,910 houses to the eligible beneficiaries.

The Ministry had allocated a total target of 2,46,435 houses including 1,79,060 houses allocated during the FY 2021-22. Out of the total targets, the State had sanctioned 2,46,430 houses to the beneficiaries and 55,260 houses have been completed.

- (c): The Ministry is taking the following initiatives to ensure timely completion of the houses under PMAY-G:
  - i. Regular review of progress at the level of Ministry.
  - ii. Launch of PMAY-G analytic Dashboard for monitoring and supervision of the scheme.
- iii. Timely allocation of targets to the States/UTs and release of adequate funds.
- iv. Regular follow ups with the State to ensure release of central and state share of funds and provision of land to landless beneficiaries in rural areas.
- v. Awards to the best performing States/UTs, Districts based on performance index dashboard, thereby creating healthy competition and motivation among the States/UTs for achieving the set targets.
- (d) & (e): No, Sir. There is no such proposal under the consideration of the Ministry.
