Pradhan Mantri Matsya Sampada Yojana for Poor Fishermen

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) whether the Pradhan Mantri Matsya Sampada Yojana of Rs. 20,000 crore is being run for poor fishermen and if so, the details thereof;
- (b) whether 60 percent of the funds have to be invested by the beneficiaries under the said yojana;
- (c) if so, the manner in which the poor fishermen are likely to be benefited; and
- (d) the details of amount released so far under the said yojana, State-wise?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

(SHRI PARSHOTTAM RUPALA)

(a) to (d): The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying is implementing a flagship scheme namely "Pradhan Mantri Matsya Sampada Yojana (PMMSY) with an investment of Rs.20050 crore in fisheries sector. This scheme is implemented in all the States/Union Territories (UTs) for a period of 5 years with effect from the financial year 2020-21 for holistic development of fisheries sector and welfare of fishers. Under this scheme, financial assistance is provided to various beneficiaries including fishermen and fish farmers for taking up activities relating enhancement of fish production and productivity, quality, technology, post-harvest infrastructure and management, modernisation and strengthening of value chain, traceability, establishing a robust fisheries management framework and fishers' welfare. The Government financial assistance for beneficiary oriented activities is limited to 40% of the project/unit cost for General category and 60% of the project/unit cost for SC/ST/Women and as such the remaining 60% and 40% respectively is invested by the beneficiaries for taking up intended activities under this Scheme.

During the last three financial years (FY 2020-21, 2021-22 and 2022-23) and till date of current financial year (2023-24), the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying has accorded approvals to the proposals worth of Rs. 15822.54 crore with a central share of Rs. 6546.57 crore and central funds of Rs. 3051.25 crore has been released to various State Governments/Union Territories and other implementing agencies for development of fisheries sector and benefits of fishers and other stakeholders. The State-wise details of the funds released so far under PMMSY is furnished at Annexure-I.
