## LOK SABHA UNSTARRED QUESTION NO. 3205 TO BE ANSWERED ON 08.08.2023

### **Pensions to Sportspersons**

#### 3205. SHRI KARTI P. CHIDAMBARAM:

Will the Minister of Youth Affairs and Sports be pleased to state:

- (a) the details of facilities provided by the Government to sportspersons after retirement;
- (b) whether the Government provides adequate pensions to sportspersons after retirement and if so, the details thereof;
- (c) whether the Government provides medical facilities and adequate medical insurance to sportspersons after retirement and if so, the details thereof;
- (d) whether the Government has provisions for employment to sportspersons after retirement and if so, the details thereof;
- (e) the details of the initiatives taken by the Government to provide housing or accommodation facilities to retired sportspersons, particularly those who have represented the country at the international level; and
- (f) the steps taken by the Government to encourage corporate sponsorships or endorsements for retired sportspersons to enhance their financial stability and if so, the details thereof?

#### ANSWER

### THE MINISTER OF YOUTH AFFAIRS AND SPORTS [SHRI ANURAG SINGH THAKUR]

- (a) and (b): The Government is implementing the 'Scheme of Sports Fund for Pension to Meritorious Sportspersons' which provides additional financial security to sportspersons, after their retirement from an active sports career in the form of life-time pension ranging from Rs. 12,000/- to Rs. 20,000/- per month for winning medals in Olympic Games, Paralympic Games, World Cup, World Championships, Asian Games, Para Asian Games and Commonwealth Games.
- (c): Financial assistance upto Rs. 10.00 Lakh for medical treatment to sportspersons or family members is provided under the scheme of 'Pandit Deendayal Upadhyay National Welfare Fund for Sportspersons' (PDUNWFS).
- (d): The Sports Authority of India (SAI), an autonomous organization under Ministry of Youth Affairs and Sports has a separate cadre of coaches. All the coaches recruited in SAI are sportspersons. Out of 3560 sanctioned posts, 1524 are sportspersons by virtue of their engagement as coaches. Out of 1524 Coaches, 5% posts are reserved for Olympians and 1% for Paralympians at the entry cadre. Also, 3% posts are reserved for Medal Winning Olympians or for those with representation in two Olympic Games and 2% posts are reserved for medal winning Paralympians in the grade of Coach (Level-10).

As a part of Government's vision to strengthen the sports ecosystem in the country at the grass root level, a low-cost, effective Sports training mechanism has been developed wherein the past 'Champion Athlete' become coaches and mentors at Khelo India Centres. At present, 635 past champion Athletes have been engaged in various Khelo India Centres across the country.

(e) and (f): There is no such provision under the Scheme of 'Sports Fund for Pension to Meritorious Sportsperson'.
