HEALTHCARE FACILITIES UNDER AYUSHMAN BHARAT YOJANA

333. MS. CHANDRANI MURMU:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details regarding the total number of beneficiaries under Ayushman Bharat Yojana;
- (b) the total amount of fund disbursed under the said scheme since its inception till date, State/UT/Year-wise;
- (c) whether due to non-implementation of the Yojana by some States a number of people are unable to avail its benefits and if so, the number of such people, State/UT-wise; and
- (d) the details of the healthcare facilities covered under Ayushman Bharat Yojana, State/UT-wise and district-wise in Odisha?

(a) to (d): Ayushman Bharat –Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) is the world's largest publicly funded health protection scheme which aims to provide health cover of Rs. 5 lakh per family per year for secondary and tertiary care hospitalization to 55 crore individuals corresponding to 12 crore families. Many States/UTs implementing AB-PMJAY have expanded the beneficiary base to approximately 15.5 crore families at their own cost. State/UT/Year-wise details of fund released under the scheme since its inception are at Annexure-I.

AB-PMJAY is implemented in 33 States/UTs except for Delhi, Odisha and West Bengal. The number of eligible families under the scheme in Delhi, Odisha and West Bengal is 6.54 lakh, 67.80 lakh and 1.24 crore respectively. Government of India is pursuing with these States/UT to join the scheme so that eligible beneficiaries are not deprived of healthcare benefits.

As of 12th July 2023, a total of 27,012 hospitals, including 11,878 private hospitals, are empaneled across the country to provide healthcare services to the scheme beneficiaries. State/UT-wise details of hospitals empaneled under the scheme are at Annexure-II. In order to provide healthcare services to beneficiaries from other States/UTs under portability feature of the scheme, 28 hospitals are empaneled in Odisha. District-wise details of hospitals empaneled under the scheme in Odisha are at Annexure-III.
