# GOVERNMENT OF INDIA MINISTRY OF ELECTRONICS AND INFORMATION TECHNOLOGY LOK SABHA UNSTARRED QUESTION NO. 3347 TO BE ANSWERED ON 09.08.2023

### ISSUE OF AADHAAR CARD IN GUJARAT

### 3347. SHRI VINOD L. CHAVDA:

Will the Minister of ELECTRONICS AND INFORMATION TECHNOLOGY be pleased to state:

(a) the total number of citizens to whom Aadhaar number is yet to be issued by the UIDAI in the country including Gujarat, district-wise; and

(b) the efforts being made by the Government to issue Aadhaar number to persons to whom Aadhaar Number is yet to be issued in Gujarat particularly in the districts of Kutch Lok Sabha constituency along with the outcome thereof?

### ANSWER

## MINISTER OF STATE FOR ELECTRONICS AND INFORMATION TECHNOLOGY (SHRI RAJEEV CHANDRASEKHAR)

(a): The Unique Identification Authority of India provides digital identity (Aadhaar) and digital authentication services to all the residents of India. As per sub-section (1) of section 3 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016, every resident is entitled to obtain an Aadhaar number by submitting the requisite information and undergoing the enrolment process. Accordingly, every resident who is desirous of obtaining an Aadhaar number and who undergoes the enrolment process by submitting the requisite information is issued an Aadhaar number. As on 30.06.2023, after adjusting for the estimated number of deaths, the estimated number of living Aadhaar number holders is 130.20 crore across India, including 6.55 crore in the State of Gujarat. District-wise details of Aadhaar numbers issued in Gujarat are at Annex.

(b): As on 30.6.2023, over 63,000 Aadhaar centres were operational across India, including 3,393 centres in Gujarat. In addition, the facility of enrolment of children below the age of five years is available through around 28,000 handheld mobiles/tablets operated by postmen, hospital staff, etc., including 1,041 handheld mobiles/tablets in Gujarat. The details of such centres and mobiles/tablets available in the districts falling in the Kachchh(Kutch) Lok Sabha constituency are as under:

In addition to enrolment at the centres and through mobiles/tablets as above, the Unique Identification Authority of India (UIDAI) organises Aadhaar enrolment camps through enrolment Registrars authorised/recognised by it to enrol residents. During the financial year 2022-2023, more than 9 lakh residents were enrolled in 70,750 camps held in the State of Gujarat, including 2,596 camps held in Kachchh District and 406 camps held in Morbi District.
