"PROMOTION OF HERBAL GARDENS"

350. SHRI RAJU BISTA: MS. RAMYA HARIDAS:

Will the Minister of Ayush be pleased to state:

- (a) the details of the implementation of promotion of "Herbal Garden" under the "Central Sector Scheme on Conservation, Development and Sustainable Management of Medicinal Plants', State/UT-wise;
- (b) the details of the funds allocated and utilized for individual home Gardens, School Herbal Gardens, Institutional/Public Herbal Gardens and Herbal Gardens of State and national importance developed under the scheme, State/UT-wise;
- (c) the details of the funds allocated and utilized under the scheme in West Bengal, district-wise and project-wise;
- (d) the details of the herbal gardens functioning in the country, State/UT-wise particularly in Kerala;
- (e) whether any such garden is presently functioning in Kerala along with the status of sanctioned projects to support herbal gardens during the last five years and the current year; and
- (f) if so, the details thereof along with details of the funds sanctioned and allocated for the said projects and if not, the reasons therefor?

ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) & (b) The 'National Medicinal Plants Board', Ministry of Ayush is implementing a "Central Sector Scheme on Conservation, Development and Sustainable Management of Medicinal Plants" throughout the country under which there is a provision to provide project based support to various Government and Non-Government organizations to develop different types of Herbal Gardens viz. Home Herbal Garden (now removed from scheme), School Herbal Gardens, Institutional/ Public Herbal Gardens and Herbal Gardens of State and National importance. The State/UT–wise detail of different types of Herbal Gardens supported during last five years and current year along with funds sanctioned and utilized is given at **Annexure – I & II** respectively.

(c) The details of the funds sanctioned and utilized for development of different type herbal gardens under the scheme in West Bengal, district-wise and project-wise is given at **Annexure** – **III**.

(d) The details of the Herbal Gardens functioning in the country, State/UT-wise including Kerala is given at Annexure – IV.

(e) & (f) Yes Sir/Madam, such Herbal Gardens are presently functioning in Kerala the details of the funds sanctioned, projects supported for herbal gardens during the last five years and the current year are given at Annexure – V.
