Implementation of JJM

†3504. SHRI RAHUL KASWAN:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether the Union Government provides funds for implementation of Jal Jeevan Mission (JJM) to State Governments which are responsible for implementation of the same;
- (b) the details of the funds disbursed by the Union Government to State Government of Rajasthan so far under JJM and the status of its utilization thereof, year and district-wise;
- (c) whether a provision has been made to connect the hamlets outside the previously identified villages under JJM;
- (d) if so, the time by which it is likely to be done; and
- (e) if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE OF JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a) to (e) Drinking Water being a State subject, it is States, who plan, design, approve and implement drinking water supply schemes. Government of India supplements the efforts of the States by providing technical and financial assistance. Since August 2019, Government of India, in partnership with States, is implementing centrally sponsored programme Jal Jeevan Mission (JJM)-Har Ghar Jal to enable all rural household identified by the respective state government, to have assured potable water through tap connection, by 2024.

Further, States carry out survey in respect of number of rural households which are to be provided with tap water connection and update the same on JJM-IMIS portal. At the time of announcement of Jal Jeevan Mission, 3.23 Crore (17%) rural households were reported to have tap water connections. So far, as reported by States/ UTs as on 07.08.2023, around 9.52 Crore additional rural households have been provided with tap water connections. Thus, as on 07.08.2023, out of 19.41 Crore rural households in the country, around 12.75 Crore (65.69%) households are reported to have tap water supply in their homes and the remaining 6.66 Crore (34.31%) are likely to be covered by 2024.

District-wise fund allocations and its utilization are not made and maintained by this department. However, year-wise details of Central fund allocated, fund drawn and fund utilization reported by the State of Rajasthan is as under:
