"QUALITY AND PRICES OF AYUSH MEDICINES"

Will the Minister of **AYUSH** be pleased to state:

(a) whether the Government is aware of the steep increase in the prices of AYUSH medicines particularly Ayurvedic, Homoeopathic in recent times and if so, the details thereof along with reasons therefor;

(b) whether any study has been conducted regarding the efficacy of quality and price of AYUSH medicines and any mechanism has been put in place to ensure the availability of medicines through Jan Aushadhi outlets, if so, the details thereof along with the steps taken/proposed to be taken by the Government to provide quality AYUSH medicines at affordable rates;

(c) whether the Government has any plans to ensure adequate availability of AYUSH medicines/ drugs in the country particularly Ayurvedic medicines at Jan Aushadhi outlets and if so, the details thereof;

(d) whether the Government has taken/proposes to take any stringent measures to control and curb the sale and distribution of spurious Ayurvedic and Unani medicines in the country; and(e) if so, the details thereof along with the list of such cases registered and action taken thereon, State/UT-wise, year-wise during the last five years and the current year?

ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) Prices of Ayush medicines manufactured by Indian Medicines Pharmaceutical Corporation Limited (IMPCL), the public sector manufacturing unit of the Ministry of Ayush, are determined

by Department of Expenditure, Ministry of Finance, Government of India. Further, no steep increase in the prices of Ayush medicines has been noted.

(b) Under Rule 158 B of Drugs & Cosmetics Rules, 1945, guidelines for issue of license and requirement of safety study and Experience/ Evidence of effectiveness with respect to Ayurveda, Siddha or Unani drugs has been prescribed. It is mandatory for the manufacturers to adhere to the prescribed requirements for licensing of manufacturing units & medicines including proof of safety & effectiveness, compliance with the Good Manufacturing Practices (GMP) as per Schedule T and Schedule M-I of Drugs and Cosmetics Rules, 1945 and quality standards of drugs given in the respective pharmacopoeia. Further, no study has been conducted regarding the price of Ayush medicines.

Ayush medicines manufactured by IMPCL are quality checked by Quality Assurance/ Quality Control department and NABL accredited laboratories. IMPCL supplies Ayush medicines as per the order received from various government organizations/ institutions.

With an objective of making quality generic medicines available at affordable prices to all, Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP) was launched by the Department of Pharmaceuticals, Ministry of Chemicals & Fertilizers, Government of India. Under this scheme, dedicated outlets known as Pradhan Mantri Bhartiya Janaushadhi Kendra (PMBJK) are opened to provide generic medicines at cheaper rates to the citizens of the country. The product basket of Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP) comprises 1800 medicines and 285 surgical devices covering all major therapeutic groups such as Cardiovascular, Anti-cancers, Anit-diabetics, Anti-infectives, Anti-allergic, Gastro-intestinal medicines, Nutraceuticals, etc. In addition to this, various nutraceutical products like Protein Powder, Malt-based Food Supplements etc. are available. Prices of the Jan Aushadhi medicines are generally 50%-90% less than that of branded medicines prices which are available in the open market.

(c) Ayush products, viz. Ayu Raksha Kit, Bal Raksha Kit and Ayush-64 tablet and *Chywanprash*, *Triphala*, *Shilajit* and *Ashwagandha* have been added in the product basket of the Pradhan Mantri Bhartiya Janaushadhi Kendra (PMBJK) which is being made available through selected Kendras. Ayush products supplied by IMPCL to Jan Aushadhi are in various kit form comprising of *Ayush Kwath*, *Anu taila*, *chyavanprash*, *Shamshamni vati*, *Bal Ayush Kwath Syrup*, *Ayush-64* and *Ashwagandha* tablets during pandemic. Presently only *Ashwagandha* tablets are being supplied as per existing tender.

(d) and (e) Yes sir. Provisions related to spurious Ayurveda, Siddha and Unani drugs are prescribed under Section 33EEA and penalty for manufacture for sale or for distribution of any such drugs are prescribed under section 33 I of Drugs and Cosmetics Act, 1940. Further, Rule 159 of Drugs and Cosmetics Rules, 1945 have provisions for cancellation or suspension of licences if the licensee has failed to comply with any of the conditions of the licence or with any provisions of the Drugs and Cosmetics Act, 1940 or the rules made thereunder.

As prescribed in Drugs and Cosmetics Act 1940 and Rules 1945 made thereunder, enforcement of the legal provisions pertaining to Quality Control and issuance of drug license of Ayurveda, Siddha and Unani drugs, is vested with the State Drug Controllers/ State Licensing Authorities appointed by the concerned State/ Union Territory Government.

Rule 160 A to J of the Drugs and Cosmetics Rules, 1945 provides the regulatory guidelines for approval of Drug Testing Laboratory for carrying out such tests of identity, purity, quality and strength of Ayurvedic, Siddha and Unani drugs as may be required under the provisions of these rules, on behalf of licensee for manufacture of Ayurvedic, Siddha and Unani drugs. As on date, 35 State Drug Testing Laboratories have been supported for strengthening their infrastructural and functional capacity. Further, 95 laboratories are approved or licensed under the provisions of Drugs and Cosmetics Rules, 1945 for quality testing of Ayurvedic, Siddha and Unani drugs and raw materials.

One Ayurvedic medicine were noticed as misbranded and spurious medicine under D & C Act, 1940 and the same has been reported to Drug Licensing Authorities of concerned States/UTs.

As per the information received from State/ UT governments, the details of sale and distribution of spurious Ayurvedic and Unani medicine and action taken during the last five years and the current year are at **Annexure**.
