PMBJKs in Karnataka

3783. SHRI ANNASAHEB SHANKAR JOLLE:

Will the Minister of **CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) whether the Government has details about the number of Pradhan Mantri Bhartiya Janaushadhi Kendras (PMBJKs) established in the State of Karnataka since the inception of the scheme;
- (b) if so, the details thereof, district-wise;
- (c) whether any financial/special support is provided to applicants belonging to SC/ST for setting up of Janaushadhi Kendra;
- (d) if so, the details thereof;
- (e) whether the Government conducts regular quality checks/audits at such stores to ensure good quality medicines for the patients; and
- (f) if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI BHAGWANTH KHUBA)

- (a) & (b): Under the *Pradhan Mantri Bhartiya Janaushadhi Pariyojana* (PMBJP) about 9,668 *Pradhan Mantri Bhartiya Janaushadhi Kendra*s (PMBJKs) have been opened as on 31.07.2023 all across the country. Out of which, about 1,088 PMBJKs have been opened in the State of Karnataka. District- wise list is enclosed as **Annexure.**
- (c) & (d): All PMBJK owners are provided an incentive up to Rs. 5.00 lakh @ 15% of monthly purchases made by them, subject to a ceiling of Rs. 15,000/- per month. In addition, one-time incentive of Rs. 2.00 lakh is provided to the PMBJKs opened in North-Eastern States, Himalayan areas, Island territories and areas mentioned as aspirational district by NITI Aayog or opened by women entrepreneur, ex-serviceman, Divyang, SC & ST for furniture and fixyures.
- (e) & (f): Pharmaceuticals & Medical Devices Bureau of India (PMBI), the implementing agency of the scheme, procures medicines only from World Health Organization Good Manufacturing Practices (WHO-GMP) certified suppliers for ensuring quality of the products. Further, each batch of drug is tested at laboratories accredited with 'National Accreditation Board for Testing and Calibration Laboratories' (NABL) before their dispatch to PMBJKs. Marketing Officers of PMBI periodically inspect PMBJKs to ensure that good quality medicines are provided to the patients.
