ONE STOP CENTRE SCHEME

3811. SHRI JAYANT SINHA:

Will the Minister of Women and Child Development be pleased to state:

- (a) the rationale and salient features of the One Stop Centre (OSC) for women;
- (b) the details of the progress made towards achieving the scheme's objective of providing a range of services to women affected by violence, including medical, legal and psychological support; and
- (c) the total number of OSCs in the country, State/UT-wise including Jharkhand, district-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) to (c): The Government has been implementing the scheme of One Stop Centre (OSC) since 1st April, 2015 to provide a range of integrated services under one roof to women affected by violence and in distress. These services include Police facilitation, medical aid, providing legal aid and legal counselling, psycho-social counselling and temporary shelter. So far, a total of 801 One Stop Centres have been approved in all 36 States/UTs, out of which 733 OSCs are functional including all 24 districts of Jharkhand, which have assisted more than 7.06 lakh women up to March, 2023 across the country. The total number of OSCs in the country, State/UT-wise including Jharkhand, district-wise is attached at **Annexure**.

A third party evaluation of the schemes of the Ministry, including One Stop Centre (OSC) Scheme, was conducted during the Financial Year 2020-21 through NITI Aayog. The study found the relevance, effectiveness and sustainability of the scheme as satisfactory. Based on the recommendations of the Third Party Evaluation, the OSC scheme has been included as a component of sub-scheme 'Sambal' under Mission Shakti for implementation during period of 15th Finance Commission Cycle upto 2025-26. The Mission Shakti aims at strengthening interventions for safety, security and empowerment of women in a mission mode through institutional and convergence mechanism. The OSC has been designated a mainstay at district level for all activities related to safety and security of women and girls.

Further, the Government has also engaged the services of National Institute of Mental Health and Neuro Sciences (NIMHANS) for providing basic and advanced training under the project named 'Stree Manoraksha' to the staff of One Stop Centres (OSCs) across the country on handling psycho-social and mental health care needs of women facing violence and in distress.
