SAKSHAM AND SABLA SCHEME

3846. SHRI T.N.PRATHAPAN

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether the SAKSHAM-Rajiv Gandhi Scheme for Empowerment of Adolescent Boys has failed to reach the beneficiaries;
- (b) if so, the details thereof;
- (c) whether the Government has the record of the total number of adolescent boys and girls in respective Anganwadi areas, ward, panchayat and districts and if so, the details thereof; and
- (d) the details and the progress of the SABLA scheme under the umbrella of Integrated Child Development Services?

ANSWER

- (a) to (c) The Rajiv Gandhi Scheme for Empowerment of Adolescent Boys was announced on 27.02.2014 by the previous Government and was not implemented.
- (d) For self-development and empowerment of adolescent girls in the age group of 11-18 years, SABLA was launched in 2010 on pilot basis in 205 districts of the country. The scheme was renamed as Scheme for Adolescent Girls and extended to additional 303 districts across the country in 2017-18. Thereafter, with effect from 01.04.2018, the Scheme was extended to all the districts of the country covering only out-of-school adolescent girls in the age group of 11-14 years.

With the enforcement of Right to Education Act, 2009, there was a decline seen in the number of beneficiaries of the Scheme since the RTE Act provides legal entitlement for compulsory and free education to adolescent girls in the age group of 11-14 years and all the adolescent girls are entitled to go to school.

Keeping this in view, Scheme for Adolescent Girls was revised w.e.f. 01.04.2022 and was subsumed under Mission Saksham Anganwadi and Poshan 2.0. The Scheme aims at providing nutritional support to Adolescent Girls (14-18 years) for improving their health and nutritional status in the Aspirational Districts and all districts of North Eastern States. Under the Scheme, services are provided under following Components:

- (i) **Nutrition:** There is a provision of providing supplementary nutrition containing 600 calories, 18-20 grams of protein and micronutrients to adolescent girls in the age group of 14-18 years for 300 days in a year.
- (ii) **Non Nutrition Component:** There is a provision for providing IFA supplementation, Health check-up and Referral services, Nutrition & Health Education and Skill Training

Under the Scheme for Adolescent Girls (SAG), State-wise number of beneficiaries as reported in the Poshan Tracker, during the current financial year is as below:
