SAFETY ON WATERWAYS

3879. SHRI S. MUNISWAMY:

Will the Minister of PORTS, SHIPPING AND WATERWAYS be pleased to state: पत्तन, पोत परिवहन और जलमार्ग मंत्री

(a) whether the Government identified particular waterways which are important from the point of view of tourists and if so, the details thereof;

(b) whether the Government has been able to maintain the safety standards at these waterways and if so, the details thereof; and

(c) whether the Government is inclined to having the safety matters of waterways looked after by reputed life saving organizations and if so, the details thereof?

ANSWER

MINISTER OF PORTS, SHIPPING AND WATERWAYS (SHRI SARBANANDA SONOWAL)

(a) Yes, Sir. A study was conducted by Inland Waterways Authority of India (IWAI) in November 2022 for preparation of an Action Plan and Detailed Road Map for development of river cruise tourism in India, which also identified potential NWs for river cruise tourism. Details of potential NWs indentified for river cruise tourism is at **Annexure-1**.

(b) & (c)Government has notified on 07.06.2022 the safety rules viz. (i) The Inland Vessels (Safe Navigation, Communication and Signals) Rules (ii) The Inland Vessels (Life Saving Appliances) Rules (iii) The Inland Vessels (Fire Fighting Appliances) Rules under the Inland Vessels Act, 2021. The responsibility of the implementation of rules and regulations related to safety of inland vessels primarily rests with the State Governments. The responsibility of issue of Survey and Registration Certificates of inland vessels plying in rivers, lakes etc. also lie with the State Governments as per Inland Vessels Act, 2021.
