COVERAGE UNDER POSHAN ABHIYAAN

418. SHRI MANOJ TIWARI:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the details of the districts covered under 'POSHAN Abhiyaan' in Jharkhand along with the details of Anganwadi centres in each district;
- (b) the details of the funds released under the POSHAN Abhiyaan to the NCT of Delhi by the Government during the last three years, year and district-wise; and
- (c) the details of the funds released and number of beneficiaries covered under the scheme for adolescent girls and the Pradhan Mantri Matru Vandana Yojana during the said period in Delhi, year and district-wise?

- (a) The details of districts covered under Poshan Abhiyaan in Jharkhand along with the details of Anganwadi Centers are annexed at A1.
- (b) The funds under Poshan Abhiyaan are released State/UT. Data for further district-wise allocation is not maintained by the Ministry. During the last three years a fund of Rs. 188.6 lakhs has been released for NCT of Delhi under Poshan Abhiyan.
- (c) The details of the funds released and number of beneficiaries covered under the Scheme for Adolescent Girls are as under:

The Scheme for Adolescent Girls (SAG) has been revised and subsumed under Saksham Anganwadi and Poshan 2.0 during 2022-23. Under the revised Scheme, Adolescent Girls (AGs) in the age group of 14-18 years in NER and Aspirational Districts will be covered under SAG.

Under Pradhan Mantri Mandru Vandana Yojana, during the financial years 2020-21, 2021-22 and 2022-23, Rs. 5.46 crore, 28.31 crore and 31.46 crore have been released as central share for the scheme to NCT of Delhi. Further, district-wise details of beneficiaries enrolled under PMMVY scheme in Delhi UT during the financial years 2020-21, 2021-22 and 2022-23 is as under:
