## **UPGRADATION OF SHS INTO NHS**

# be pleased to state:

- (a) the criteria adopted for conversion/upgradation of various State Highways (SHs) into National Highways (NHs) in the country;
- (b) the details of the roads converted to NHs in the country during the last five years, State-wise including Bundelkhand;
- (c) the details of SHs identified for upgradation into NHs in the country under the National Highways Development Project (NHDP), State-wise particularly in Rajasthan and Bundelkhand;
- (d) the funds sanctioned so far for the said projects; and
- (e) whether there is any scheme to operate toll free roads in economically backward areas of the country, particularly in Bundelkhand and if so, the details thereof?

#### **ANSWER**

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

- (a) State roads, including State Highways (SHs), are declared as National Highways (NHs) from time to time on the basis of well established principles. The important criteria for declaration of NHs include the following:
  - i. Roads running through length / breadth of the country.
  - ii. Connecting adjacent countries, National Capitals with State Capitals / mutually the State Capitals, major ports, non-major ports, large industrial centers or tourist centers.
- iii. Roads having important strategic requirement in hilly and isolated area.
- iv. Arterial roads which enable sizeable reduction in travel distance and achieve substantial economic growth.
- v. Roads which help in opening up large tracts of backward area and hilly region.
- vi. Roads contributing towards achievement of National Highways grid of 100 km.
- vii. Synergy with PM GatiShakti National Master Plan (NMP).
- (b) State / Union Territory (UT) wise details of State roads, including SHs, notified as NHs during the last five years, including for the States of Madhya Pradesh and Uttar Pradesh, are placed at Annexure-I.
- (c) The Ministry keeps on receiving proposals from various State Governments / UTs, including from the State Governments of Rajasthan, Madhya Pradesh and Uttar Pradesh, for declaration / upgradation of State roads, including SHs, as new NHs. Decisions are taken based on the fulfillment of the criteria, requirement of connectivity, inter-se priority and availability of funds.

National Highways Development Project (NHDP) has been subsumed under Phase-I of Bharatmala Pariyojana (BMP). State / UT – wise details of State roads, including SHs, notified as NHs under BMP, including for the States of Rajasthan, Madhya Pradesh and Uttar Pradesh, are placed at Annexure-II.

(d) The year-wise details of funds released / expenditure incurred by the Ministry for projects under BMP during the last five years and the current year are as follows: -

(e) User Fee collection on NHs and exemption of vehicles plying on NHs from paying the User Fee are as per the National Highways Fee Rules, 2008, as amended from time to time.
