GEO-MAPPING OF ANGANWADI CENTRES

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of Anganwadi Centres (AWCs) running in the country at present;
- (b) whether the Union Government is collaborating with a Gujarat-based agency to geo-map all AWCs, if so, the details and the facts thereof;
- (c) whether the Union Government is also collaborating with other institutions in the country in this regard, if so, the details thereof;
- (d) the percentage of beneficiaries registered on the Poshan Tracker verified with Aadhaar so far, State/UT-wise particularly in Odisha;
- (e) whether there is any proposal to integrate Poshan Tracker with Reproductive and Child Health (RCH) portal of Ministry of Health and Family Welfare; and
- (f) if so, the details and the present status thereof?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) At present, a total of **13.96 lakh** Anganwadi Centres are registered on Poshan Tracker, the ICT application that monitors the service delivery under Anganwadi Services on select indicators.

(b) to (c) Under the PM Gati Shakti programme managed by Department for Promotion of Industry and Internal Trade (DPIIT), this Ministry has initiated geo-mapping of all AWCs through the Poshan Tracker application. The data is being mapped on the Gati Shakti portal in collaboration with Bhaskaracharya National Institute of Space Application and Geo-Informatics (BISAG-N) which is an agency under MeitY, Government of India. So far, close 10.3 lakh AWCs in the country have been geo-mapped.

This will offer a judicious technique for policy planning and interventions, e.g., easy identification of available land for setting up Anganwadi Centres, population size, proximity to water resources, medical facilities, educational institutions, rail heads, locating Gram Panchayats with wifi facilities etc., hence enabling ready access to information for focused nutrition and gender services.

(d) The State/UT - wise percentage of beneficiaries registered on the Poshan Tracker application verified with Aadhar, including Odisha, is at Annexure 1.

(e) & (f) The Integration of RCH Portal of MoHFW with the POSHAN Tracker of MoWCD is in process. At present, based on Aadhar and ABHA id, facility to fetch health records of pregnant women, such as, Last Menstrual Period date, Date of Tetanus Dose, Details of Ante Natal Care, Haemoglobin etc, from RCH has been provisioned on Poshan Tracker.
