**PMMVY BENEFICIARIES IN MAHARASHTRA**

455. SHRI SUNIL DATTATRAY TATKARE:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- whether the Government has launched Pradhan Mantri Matru Vandana Yojana (PMMVY) for maternity benefits to the pregnant women;
- if so, the details of number of beneficiaries benefitted under the scheme during the last five years, State/UT-wise including Maharashtra; and
- the budgetary allocation and actual expenditure under the PMMVY during the last five years, year-wise?

**ANSWER**

(a) The Ministry of Women and Child Development is implementing Pradhan Mantri Matru Vandana Yojana (PMMVY) across the country through State Governments/Union Territory Administrations w.e.f. 01.01.2017. The PMMVY is a Centrally Sponsored Maternity Benefit Scheme under which cash incentives of ₹5,000/- is provided directly to the Bank/Post Office account of the beneficiary in Direct Benefit Transfer (DBT) mode for first child. The eligible beneficiaries receive the remaining cash incentive, as per approved norms towards maternity benefit under Janani Suraksha Yojana after institutional delivery, so that on an average a woman gets ₹6,000/-. Cash incentive of ₹6,000/- is also provided under PMMVY to eligible beneficiaries for second child subject to the second child being a girl.

(b) Details of number of beneficiaries provided maternity benefits under PMMVY, State-wise, during the last five years is **Annexed**.

(c) The details of Budget Estimates (BE), Revised Estimates (RE) and actual expenditure under PMMVY during the last five years is as under:
