Rehabilitation of Displaced Villages

475. SHRI MOHAN MANDAVI:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the details of measures taken for conservation of forests in the country along with the details of increase in forest cover as a result of the said measures, State-wise including Chhattisgarh;
- (b) the details of activities carried out and total funds spent thereunder, State-wise including Chhattisgarh;
- (c) the number of forest villages and tribal dominated villages that have been displaced;
- (d) the details of the scheme for rehabilitation of displaced villages, State-wise including Chhattisgarh; and
- (e) whether all the displaced villages have been rehabilitated and if so, the details thereof, State-wise including Chhattisgarh?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI ASHWINI KUMAR CHOUBEY)

(a) & (b) For restoration and conservation of forests, the Government of India is implementing various centrally sponsored umbrella schemes in States/UTs, including Chhattisgarh. These include National Mission for a Green India (GIM), Nagar Van Yojna (NVY), Integrated Development of Wildlife Habitats, and Forest Fire Prevention and Management (FFPM) scheme. The funds collected under Compensatory Afforestation Fund Management and Planning Authority (CAMPA) as compensatory levies from states are also used for plantation activities by States/UTs. The schemes primarily support ecological restoration through afforestation in and outside forest areas, forest landscape restoration, habitat improvement, soil and water conservation measures and protection etc.

The details of funds provided by the Central Government under NVY and FFPM schemes to various States/UTs during the last three years are given in **Annexure-I**.

GIM activities were started in the FY 2015-16. So far, a sum of ₹755.28 Crores has been released. The State/UT wise details of the funds released under GIM are given at Annexure-II

The details of CAMPA funds utilized by the States/UTs during 2020-21 to 2022-23 are enclosed at **Annexure-III**.

As per the India State of Forest Report (ISFR) 2021, the details of States/UTs where forest cover has increased as compared to ISFR (2019) are given at **Annexure-IV.**

(c) to (e) The Central Government gets proposals from various States/UTs for conversion of forest villages into revenue villages and voluntary village relocation under the provisions of the Forest (Conservation) Act, 1980 from time to time.

The Government of India vide letter F. No. 8-34/2017-FC dated 20th May 2019 has issued Guidelines for relocate ion of villages in accordance with the directions of the Hon'ble Supreme Court in order dated 28th January, 2019, regarding relocation/rehabilitation of the villages from the core/critical Tiger reserves and critical habitats of the Protected Areas (National Parks and Wildlife Sanctuaries) to the periphery of Reserved Forest/Sanctuaries/National Parks subject to certain conditions.

As per the information available on the PARIVESH portal, the details of such proposals approved by the Central Govt. under FCA,1980 during 2019-20 to 2022-23 are annexed at **Annexure-V**.

However, in case any Project Affected Person (PAP) is required to be relocated from the forest area proposed to be diverted under Forest (Conservation) Act, 1980, the same is done by the State Government as per the Rehabilitation & Resettlement (R&R) plan prepared by the concerned State Government. Further, the information regarding such displaced villages is not maintained at the Ministry level.
