- (a) the objectives of Pradhan Mantri Poshan Shakti Nirman (PM POSHAN) Scheme;
- (b) whether such scheme is being implemented in Gujarat;
- (c) if so, the details thereof; and
- (d) the details of funds allocated to Gujarat, district-wise?

ANSWER

- (a): The objectives of Pradhan Mantri Poshan Shakti Nirman (PM POSHAN) Scheme are to address two of the pressing problems for majority of children in India, viz. hunger and education by:
 - i. Improving the nutritional status of children studying in Bal Vatika (just before class I) and classes I–VIII in Government and Government-Aided Schools.
 - ii. Encouraging poor children, belonging to disadvantaged sections, to attend school more regularly and help them concentrate on classroom activities.
 - iii. Providing nutritional support to children of elementary stage in drought / disaster affected areas during summer vacation and disaster times.
- (b) to (d): The Scheme is implemented across the country including Gujarat. The Scheme covered 51,46,308 Children studying in 32523 schools in the State of Gujarat under the Scheme during 2022-23. As per information received from the State Government of Gujarat, district wise fund allocation is given at Annexure.
