FUNDS ALLOCATED TO BIHAR FOR DEVELOPMENT OF TOURISM

557. SHRI RAJIV PRATAP RUDY:

Will the Minister of TOURISM be pleased to state:

- (a) whether the Government has made any allocation for the development of tourist destinations in Bihar during the last five years;
- (b) if so, the details thereof district-wise, including Saran district;
- (c) the funds allocated district-wise in Bihar for the proposed projects and the estimated number of jobs that are likely to be created; and
- (d) the details of the investment that has taken place in the tourism sector in Bihar during the last five years?

ANSWER

THE MINISTER OF TOURISM

(a) to (d): The Ministry of Tourism has provided financial assistance under the 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' Schemes for the development of tourism related infrastructure in the State of Bihar.

Under Swadesh Darshan 2.0, Gaya & Nalanda destinations have been identified for development in the State of Bihar.

The details of projects sanctioned in the State of Bihar under the Swadesh Darshan, PRASHAD and Assistance to Central Agencies Schemes is given at Annexure. Receiving proposals from the State Governments/UT Administrations/Central Agencies for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfilment of the stipulated conditions, operational viability and availability of funds.

Development and promotion of tourism infrastructure including investment in tourism is primarily the responsibility of the concerned State Government/Union Territory Administration. However, the Ministry of Tourism has constituted Steering Committee for Investment Promotion under the Chairmanship of Secretary (Tourism) and comprising of members from various Central Ministries, NITI Aayog, Industry Stakeholders, etc. for facilitating investment in tourism sector and Public Private Partnership.
