INSPECTION COMMITTEES FOR CEMENT COMPANIES, HEAVY INDUSTRIES

†617. SHRI HANUMAN BENIWAL:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a)whether the Government has sent inspection committees in cement companies, heavy industries and refineries in the State of Rajasthan to ensure the compliance of labour laws and protection of labourer's interests;
- (b)if so, the details of enquiries made and the shortcomings found, district-wise, industry-wise and company-wise during the last five years; and
- (c) the action taken or proposed to be taken by the Government against any cement company or industry in Rajasthan with regard to noncompliance of labour laws including other complaints during the said period?

ANSWER

MINISTER OF STATE FOR LABOUR AND EMPLOYMENT (SHRI RAMESWAR TELI)

- (a): Regular inspections are conducted by the field officers of office of the Chief Labour Commissioner (Central) in the establishments (including cement companies, heavy industries and refineries in the state of Rajasthan) to ensure the compliance of labour laws in respect of which centre is the appropriate Government and to protect the interest of labourer.
- (b): The year-wise, district-wise, industry-wise and company-wise number of inspections conducted by the field officers of the Chief Labour Commissioner (Central) and irregularities detected, prosecution filed against the employer and penalty imposed for the non-compliance of the above labour laws, during the last five years are placed at Annexure –A.
- (c): In case of non-compliance of the labour laws in the establishments (including Cement Company or industry in Rajasthan) the prosecution case/ claim case against the employer are filed before the appropriate court/authority as per rules.
