643. SHRIMATI RAJASHREE MALLICK:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the total funds allocated towards Corporate Social Responsibility (CSR) by the top 25 Central Public Sector Enterprises (CPSEs) during the last five years;
- (b) the details of the expenditure of CSR amount during the above said period; and
- (c) the total CSR funds allocated and used through the CPSEs in Odisha during the abovesaid period?

(a) & (b): The broad framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. Under the Act, CSR is a Board driven process and the Board of the company is empowered to plan, decide, execute and monitor the CSR activities of the company based on the recommendation of its CSR Committee.

The CSR framework is disclosure based and CSR mandated companies are required to file details of CSR activities annually in the MCA21 registry. There is no provision of allocation of CSR Fund in Companies Act, 2013. All data related to CSR filed by companies in MCA21 registry is available in public domain at www.csr.gov.in. On the basis of the filings made by the companies in the MCA 21 registry, the details of CSR spent by top 25 (CSR expenditurewise) Central Public Sector Enterprises (CPSEs) during the financial years (FY) i.e., 2017-18, 2018-19, 2019-20, 2020-21 and 2021-22 are given below:
