SKILL DEVELOPMENT TRAINING UNDER PMKVY IN UTTAR PRADESH

650. SHRI GIRISH CHANDRA:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the number of unemployed youth in Uttar Pradesh who were provided skill development training under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY) since year 2019, year-wise;
- (b) the gender-wise percentage of candidates in Uttar Pradesh who were offered placement after training under the PMKVY since year 2019, year-wise; and
- (c) the amount of funds allocated, disbursed and utilised for the implementation of the PMKVY in Uttar Pradesh since year 2019?

(a) Ministry of Skill Development & Entrepreneurship(MSDE) launched Pradhan Mantri Kaushal Vikas Yojana (PMKVY) in 2015 for delivering skilling to the youths of the country including the State of Uttar Pradesh through Short Term Training (STT) and Recognition of Prior Learning (RPL). The number of youth in Uttar Pradesh who were provided skill development training under PMKVY since 2019, year-wiseas on 30.06.2023 is given below:

(b) Under PMKVY, placement opportunities have been provided to STT certified candidates and since RPL involves the process of certification of already existing skills, it is not linked with placements. The gender-wise percentage of candidates in Uttar Pradesh who were offered placement under STT certified component of PMKVY since 2019, year-wise is given below:

(c) PMKVY 2.0 (2016-20) and 3.0 (2020-22) were implemented through two components, viz, Centrally Sponsored Centrally Managed (CSCM) or Central Component and Centrally Sponsored State Managed (CSSM) or State Component.

Under the State Component of PMKVY 2.0 and 3.0, an amount of Rs. 156.78 and Rs 27.91 Crore was allocated to the State of Uttar Pradesh. Out of which, Rs 106.84 Crore and Rs 8.37 Crore was disbursed. The total utilization under the State Component of PMKVY 2.0 and 3.0 till 30.06.2023 is Rs 81.89 Crore.

Further, as on 30.06.2023, Rs. 1197.38 Crore has been utilized for implementation of the Central Component of PMKVY (1.0, 2.0, 3.0, 4.0)in

the State of Uttar Pradesh, details of which is given below:
