Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the details of the Government approved agro- processing clusters in the country specifically in the States of Uttar Pradesh, Madhya Pradesh, and Maharashtra;
- (b) the details of the clusters in the above specified States that are proposed to be set up in the next financial year;
- (c) the details of project's cost, grant-in-aid, etc. to be given for the above clusters; and
- (d) the likely date by which the above clusters are to become operational in these States?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a) to (c): The Ministry of Food Processing Industries (MoFPI) has been implementing the component scheme - Creation of Infrastructure for Agro Processing Cluster (APC scheme) under the umbrella scheme-Pradhan Mantri Kisan Sampada Yojana (PMKSY) w.e.f. 2017-18. Under APC scheme, as on 19.07.2023, seventy-two (72) agro processing cluster (APC) projects have been approved across the country including two projects in Uttar Pradesh, five projects in Madhya Pradesh and thirteen projects in Maharashtra. Details of the agro processing clusters (APCs) approved in the States of Uttar Pradesh, Madhya Pradesh and Maharashtra are provided in **Annexure.**

MoFPI has not decided to approve any new APCs in the States of Uttar Pradesh, Madhya Pradesh and Maharashtra in the next financial year.

(d): The timeline for completion and operationalization of APC projects is 24 months from the date of issue of approval letter for the projects in general areas and 30 months for the projects in difficult areas.
