Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the total amount invested by the Union Government for the food processing sector in West Bengal, Bihar, Jammu and Kashmir, Jharkhand and Haryana during each of the last three years, district-wise; and
- (b) the total amount of Foreign Direct Investment (FDI) received by the Union Government in the food processing sector during the last three years, State-wise?

**ANSWER**

(SHRI PRAHLAD SINGH PATEL)

**(a):** Ministry of Food Processing Industries (MoFPI) does not invest in or set up food processing industries on its own. However, it incentivizes setting up of such Industries through Grants/incentives to entrepreneurs under its Central Sector Umbrella Scheme Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) scheme across the country including West Bengal, Bihar, Jammu and Kashmir, Jharkhand and Haryana. The project details approved under PMKSY along with districts, project cost & approved Grants and details of funds released under the PMFME in West Bengal, Bihar, Jammu and Kashmir, Jharkhand and Haryana since 2020-21 is placed at **Annexure A**.

**(b):** Government has permitted 100% Foreign Direct Investment (FDI) in the food processing sector through automatic route. 100% FDI is also allowed through Government approval route for trading, including through e-commerce in respect of food products manufactured and/or produced in India. As per information provided by Department for Promotion of Industry and Internal Trade (DPIIT), state-wise details of FDI received in Food Processing Industries since 2020-21 is placed at **Annexure B**.
