Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of funds released to all States under the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) since 2014, year-wise, including Gujarat and Kerala;**
- (b) the details of projects applied, approved and executed in the State of Gujarat and Kerala under AMRUT since 2014;**
- (c) the expected dates of completion of AMRUT projects in the districts of Surat and Navsari; and**
- (d) whether it has come to the notice of the Government that the AMRUT funds are underutilized and if so, the details thereof?**

- (a): The year-wise funds released under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) to all States/ Union Territories is at ANNEXURE.**
- (b): In Gujarat, against the approved plan size of ₹4,884 crore, 453 projects worth ₹5,168 crore have been grounded of which 412 projects worth ₹4,556 crore have been completed. Overall, works worth ₹5,028 crore have been physically completed and ₹4,572 crore have been expended so far.**

In Kerala, against the approved plan size of ₹2,359 crore, 1,010 projects worth ₹2,228 crore have been grounded of which 884 projects worth ₹1,293 crore have been completed. Overall, works worth ₹1,896 crore have been physically completed and ₹1,615 crore have been expended so far.

(c): Only two cities are covered under AMRUT in the districts of Surat & Navsari of Gujarat, status of projects is as below:

(d): Under AMRUT, States have been empowered to select, apprise, propose and after approval from Apex Committee of Ministry of Housing & Urban Affairs (MoHUA), implement projects within the broad framework of AMRUT Mission. AMRUT mission was initially launched for a period of 05 years i.e. Financial Year 2015-16 to 2019-20 with committed central assistance of projects worth ₹35,990 crore. However, so far ₹33,110.41 crore has been released and ₹28,862 crore central assistance has been reported utilized by the States/ UTs. Implementation of some projects taken up under AMRUT Mission by States/ UTs have got delayed due to various reasons, such as land disputes, natural calamities, delay in obtaining clearances/permissions from other departments and disruptions/ lockdowns caused by the COVID-19 pandemic etc.
