ISSUES OF MANUAL SCAVENGERS

786. DR. A. CHELLAKUMAR: SHRI KUMBAKUDI SUDHAKARAN: DR. AMAR SINGH:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the budgetary allocations made during the last five years to eliminate manual scavenging;
- (b) whether the Self Employment Scheme for Rehabilitation of Manual Scavengers has been removed from the budget for the year 2023-24, if so, the details thereof and the reasons therefor;
- (c) whether an alternative or replacement scheme has been proposed to ensure the continued rehabilitation and empowerment of manual scavengers and if so, the details thereof;
- (d) the total number of cleaning workers killed in sewers during the last five years, State/UT-wise;
- (e) the number of cleaning workers that have been assisted by Swachhta Udyami Yojana (SUY) since the inception of the scheme, State/UT-wise;
- (f) whether the newly found robot 'Bandicoot' technology is operational and feasible to use pan India; and
- (g) if so, whether the Government has a tangible plan to implement the technology and eliminate manual scavenging in the country, if not, the reasons therefor?

ANSWER MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI RAMDAS ATHAWALE)

(a): Manual scavenging as defined under Section 2 (1) (g) of the "Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013 (MS Act, 2013)" is prohibited with effect from 6.12.2013. No person or agency can engage or employ any person for manual scavenging from that date.

The details of Funds allocated for implementation of Self Employment Scheme for Rehabilitation of Manual Scavengers during the last five years are as under:-

(b) and (c): The nomenclature of the Scheme has been changed as "National Action for Mechanised Sanitation Ecosystem" (NAMASTE) from the earlier name of "Self-Employment Scheme for Rehabilitation of Manual Scavengers" (SRMS).

To tackle hazardous cleaning specially, the Government has formulated a new scheme called 'National Action for Mechanised Sanitation Ecosystem' (NAMASTE) whose objectives are as under:-

- i. Formalization and Rehabilitation of Manual Scavengers (MS) and Persons Engaged in Hazardous Cleaning of Sewer and Septic Tank (SSWs).
- ii. Promotion of safe and mechanised cleaning of sewers and septic tanks through trained and certified sanitation workers

NAMASTE aims to achieve the following outcomes:

- a. Zero fatalities in sanitation work in India
- b. All sanitation work to be performed by formalized skilled workers
- c. No sanitation workers to come in direct contact with human faecal matter
- d. Strengthening and capacitating Emergency Response Sanitation Units (ERSUs) to ensure safe delivery of mechanized sanitation services
- e. Sanitation workers are collectivized into SHGs and are empowered to run sanitation enterprises
- f. Sewer and Septic tank sanitation workers (SSWs) and their dependents also have access to livelihoods by providing capital subsidy for purchase of sanitation related equipments.
- g. Increased awareness amongst sanitation services seekers (individuals and institutions) to seek services from registered Private Sanitation Service Organizations (PSSOs) and skilled & certified sanitation workers only.
- h. Extending Health Insurance Scheme benefits under AB-PMJAY to SSWs & manual scavengers and their family members.
- i. Occupational safety training to SSWs.
- (d): Deaths have occurred in State/UTs due to hazardous cleaning of sewers and septic tanks and non observance of safety precautions as prescribed under the "Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013 and MS Rules, 2013".

Details of cleaning workers who have lost their lives due to hazardous cleaning of sewer/septic tanks during last five years and current year are enclosed in **Annexure-I**.

(e): NSKFDC has released loans of Rs 86.84 Cr to the State Channelizing Agencies (SCAs) for procurement of mechanized cleaning equipments/ vehicles to 2509 number of beneficiaries under Swachhta Udyami Yojana (SUY) as on 30.06.2023. A Statement showing Year-wise & State-wise funds disbursed and beneficiary covered to SCAs under Swachhta Udyami Yojana is given at **Annexure-II.**

Further, Capital Subsidy of Rs. 22.93 Cr has been released for procurement of 286 units of sanitation related equipments/ projects by 641 Safai Karamcharis under SRMS. A statement showing State-wise & Year-wise details of beneficiaries covered and capital subsidy released under SRMS is given at Annexure-III

(f): The requirement which products like Bandicoot deals with, is limited to removal of accumulated grit and deposits at bottom of a manhole, which could cause choking and sewer overflows. Thus local bodies have been advised to acquire appropriate manhole de-gritting machines which can be operated without need to enter inside a manhole and also set up an appropriate cleaning periodicity. The need of periodic as well as emergency de-gritting manholes can be completed by adopting much simpler machines, easily locally fabricated which will give almost the same. If not better, output while ensuring similar level of safety for sanitation workers.

Cities have been advised to use simple, cost effective mechanical products for management of their manholes and sewers.

(g): As per Section 33 of the MS Act, 2013 every local authority and other agency are supposed to use appropriate technological appliance for cleaning of sewer and septic tanks. Government has to promote the use of modern technology through financial assistance, incentives and otherwise.

As per "Prohibition of Employment as Manual Scavengers and their Rehabilitation Rules, 2013 (MS Rules, 2013)" it is mandatory for the employer to provide the safety gear, devices and ensure safety precautions as prescribed in the Rules.

Ministry of Housing and Urban Affairs has issued Standard Operating Procedure (SOP) for cleaning of sewer and septic tanks. In addition, to this, NAMASTE scheme is being implemented in all Urban Local Bodies (ULBs) in the country as mentioned in parts (b) and (c) above.
