### PRADHAN MANTRI FORMALISATION OF MICRO FOOD ENTERPRISES

### 787. SHRI ARVIND DHARMAPURI:

Will the MINISTER OF FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the funds allocated and utilized under Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME) since its inception especially for Telangana, State-wise;
- (b) the details of the total number of beneficiaries, district-wise in Telangana and the total amount of loan disbursed to the beneficiaries since the inception of the scheme; and
- (c) whether the Government is planning to take any special steps in order to promote more participation by women, SC, ST, Minorities and other backward groups and if so, the details thereof?

#### **ANSWER**

## THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

- (a): State/UT-wise allocation of funds is not allocated under the Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) scheme. A total of ₹986.966 crores has, however, been released to different States/UTs, including ₹65.359 crores to Telangana towards implementation of the scheme. The State-wise details of fund released is given at **Annexure-I**.
- (b): The details of number of beneficiaries supported along with amount of loan disbursed to the beneficiaries since the inception of the scheme is given at **Annexure-II**.
- (c): Besides extending credit linked subsidy support to PMFME beneficiaries, Seed Capital is provided to members of women centric SHGs which are engaged in food processing activity. Establishment of Mini-TRIFOOD Units for primary and secondary processing of Minor Forest Produces is also supported under the scheme, in convergence with TRIFED. Extension of benefit of additional interest subvention is also facilitated for SC/ST beneficiaries in convergence with National Scheduled Tribes Finance & Development Corporation (NSTFDC), and National Scheduled Caste Finance & Development Corporation (NSFDC).
