Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the total funds allocated by the Government specifically for improving the dispensation and development of social justice in the country during the last three years including the financial year 2022-23, State/UT-wise particularly in Bihar;
- (b) the funds granted and utilized in this regard during the said period;
- (c) whether any review has been undertaken by the Government to know the utility of its schemes, plans and programmes during the last two years, if so, the details and outcome thereof; and
- (d) the future initiative to be taken in year 2023- 24 in this regard?

(a) to (d): The Department of Social Justice and Empowerment is implementing several Schemes for the welfare of marginalized sections of the society in the country including the State of Bihar. The details of the schemes-wise fund allocation /utilized are given in **Annexure**.

For the successful implementation of the Schemes, Government undertakes steps like mandatory annual inspections by District Authorities, Monitoring by Programme Monitoring Unit (PMU), Scrutiny of proposals by multidisciplinary State Level Grant-in-aid Committee, mandatory submission of audited statement of accounts and utilization Certificate and periodic review by holding meetings at National level, State level, District level and field visits. The Department also undertakes periodic review of the implementation of the schemes through third party evaluation studies.
