Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the details of welfare schemes launched for the weaker sections of the population across the country including Rajasthan during the last three years and the current year;
- (b) whether all the schemes have been successfully implemented to ensure the benefits of these welfare schemes to the beneficiaries;
- (c) if so, whether the Government has conducted any study/survey to ascertain the performance of these schemes at the ground level; and
- (d) if so, the details thereof?

ANSWER MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI A. NARAYANASWAMY)

(a) to (d): The Department of Social Justice and Empowerment is implementing several Schemes for the welfare of marginalized sections of the society in the country including the State of **Rajathan**. The details of the schemes-wise fund allocation /utilized are given in **Annexure**.

For the successful implementation of the Schemes, Government undertakes steps like mandatory annual inspections by District Authorities, Monitoring by Programme Monitoring Unit (PMU), Scrutiny of proposals by multidisciplinary State Level Grant-in-aid Committee, mandatory submission of audited statement of accounts and utilization Certificate and periodic review by holding meetings at National level, State level, District level and field visits. The Department also undertakes periodic review of the implementation of the schemes through third party evaluation studies.
