SHGs under IWMP

904. SHRI FEROZE VARUN GANDHI:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the number of Self-help Groups (SHGs) currently functioning under the Livelihood Activities for the Landless/Assetless Households under Integrated Watershed Management Programme (IWMP), State-wise;
- (b) the amount of seed funds released for Self-Help Groups under the Livelihood Activities for the Landless/Assetless Households under IWMP, State-wise; and
- (c) whether there are incentives provided to well-performing SHGs in terms of multiple cycles of seed money grants and if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI FAGGAN SINGH KULASTE)

(a) to (c) The Department of Land Resources (DoLR) was earlier implementing area development programmes called 'Integrated Watershed Management Programme (IWMP)' with effect from 26.02.2009. for development of rainfed/degraded areas including wastelands in the country which was amalgamated in 2015-16 with the Umbrella Scheme of PMKSY as one of components and named as the Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY). Keeping focus on the completion of the sanctioned projects, Government has not sanctioned any new watershed project under IWMP/WDC-PMKSY 1.0 from 2015-16 onwards in the country. The project period of IWMP/WDC-PMKSY 1.0 got over on 31.03.2021. However, as per requests received from various States/UTs project period was extended upto 31.03.2022 without any financial assistance.

Under IWMP/WDC-PMKSY 1.0, 9% of the total project cost was earmarked for livelihood activities for the assetless persons. Out of this fund, the eligible SHGs are provided an amount of Rs.25000 as revolving fund, which was to be refunded within a period of 18 months.

As per the information received from States/UTs, since inception, **2.47 lakh** SHGs have been formed and **Rs.837.14 crore** was given as revolving fund for taking up the income generating activities under IWMP/WDC-PMKSY 1.0. State/UT wise details are given at **Annexure**.

In addition, as per the provisions of livelihood guidelines the enterprising SHG federations could also be provided for major livelihood activities in the form of grants in aid, which was 50% of the cost of the activity or Rs.2.0 lakh whichever is less. However, grants in aid should not exceed 30% of the livelihood component (i.e. 9% of the total project cost) of the project.
